Minutes: The motion was made, seconded and unanimous vote to waive the reading and accept the minutes for the 12/0/2024 meeting as previously emailed to all officers and board of directors.

President's Report: Dave reported that he had filed an incident report concerning an out-of-battery detonation. The competitor suffered some cuts to his hand requiring band aids. It was at unload and show clear.

Charlie and CJ Freeland have reviewed the draft lease presented by El Dorado County. From this process, they have some good ideas going forward. These recommendations have been sent to Lee Smith, El Dorado Gun Club's attorney for his recommendations. We agreed that these ideas were all good and will be considered by the board after El Dorado County has rewritten or deleted the item holding individuals accountable and not El Dorado Gun Club, Inc. Lee has addressed this issue with Ted Wood, El Dorado County Counsel and believes that Ted is reconsidering the County's stand on it.

I am in the process of submitting a Request for Quote to an insurance agent that was recommended by David Richter. The Club should go ahead and purchase the insurance on the buildings at the range, if it is cost effective. The information will be presented to the Board for a vote.

I will be ordering more wattles for the rifle range to complete the job. Thank you to Chris Modlin, Roy Dickinson and Curt Tate for their help with installing the wattles on pistol, Wedge, and rifle ranges.

Vice President & Senior Range Manager Report (SRM): Bob reported that all ranges are running efficiently. Mike Hampton, Lower Range Manager, reported that the locker used to hold the Punch Cards was left unlocked. He will make the appropriate people aware.

Secretary's Report: Membership renewals are coming in. There are 33 new members for 2025.

Dave took the initiative (and responsibility) to unilaterally open the Trap Range.
