Minutes: The motion was made, seconded and unanimous vote to waive the reading and accept the minutes for the 2/11/2025 meeting as previously emailed to all officers and board of directors.

President's Report: Dave reported that he and Charlie had met with Lee Smith, Counsel for El Dorado Gun Club, at the range before Lee meets with Ted Wood, El Dorado County Counsel. Dave and Lee talked just before this meeting regarding Lee's meeting with Ted Wood. Ted Wood seems amenable to the removal of the following wording from the new lease agreement: "...and terminate the Article 10 limitation of liability." The bump in the road is the El Dorado County Department of Risk Management.

There are concerns about parking, safety issues and EMS (Emergency Medical Services) being able to get to the range with the upcoming El Dorado Gun Club Youth Trap meet on the same day as the EDPS' (El Dorado Practical Shooters) match on April 5, 2025.

Bob and Dave L will be revising and updating the Club's SOPS (Standard Operating Procedures) regarding safety policies and EMS' access to be sent to RO's (Range Officers) and placed on the Club's web page.

There was discussion of removing brush from the area near the hairpin-turn past the "Y" to the lower range. Along with other solutions to the parking problems at the ranges such as carpooling, shuttle service, and the youth trap team to park at the Old Dump and shuttle to the trap range.

Vice President & Senior Range Manager Report (SRM): Bob reported that the ranges are running well. Lower Range Manager, Mike Hampton, is doing an outstanding job of keeping all supplies on hand. The lower ranges are filled up and there are no issues.
