Private Practice: a limited privilege that allows El Dorado Gun Club Members to shoot/practice/train with likeminded Members.

Private Practice (PP) Criteria

- Only a El Dorado Gun Club (EDGC) RSO can reserve a range for PP; the RSO must be approved by the Senior Range Manager for the type of PP they want to host e.g. “from the holster”, family/friends practice/training, Action Pistol, Self-Defense, etc.
- All participants must be members of EDGC
- Maximum of four (4) hours per reservation
- Maximum of eight (8) shooters per session, unless there is a second RSO present
- Minimum of two (2) participants per session: RSO plus one
- No more than two (2) PP sessions a month per RSO
- Each PP reservation/session must be accompanied by an Open Pistol or Open Rifle reservation/session – a “one to one” trade
- PP sessions can be reserved up to two (2) months in advance
- No weekend PP sessions without authorization by the Senior Range Manager
- If the RSO *actively* participates in the session, there must be a second RSO present. Active participation *does not* include solo shooting or demonstrating a technique/drill by the RSO.
- PP sessions are “*non-compensated*” practice/training sessions. PP sessions that are in fact “*for-profit*” lessons are considered a breach of trust. The RSO will lose their RSO privileges and all participants are subject to having their EDGC membership terminated.

Fees: a \$20.00 (cash, no punch cards) range rental fee is *promised* when reserving a range for PP; the RSO reserving the PP is responsible for the rental fee; the fee covers: range rental, the RSO and one shooter.

- Each additional shooter is charged \$10.00 (cash, no punch cards)

Open Pistol or Open Rifle requirements – to qualify and RSO a PP

- The RSO reserving the PP must be the “RSO of record” (calendar) for an Open Pistol or Open Rifle session for each PP session reservation.
 - Being an *assist* RSO does not qualify
 - Being the “RSO of record” for an Action Pistol or Self-Defense Practice does not qualify
- The PP session must be held within the same calendar month or within two (2) weeks of the scheduled Open pistol or Rifle session.
- The Open Rifle or Pistol session must be posted on the EDGC calendar (“RSO of record”) for a minimum of five (5) days prior to the scheduled session date.
- The Open Pistol or Rifle session must be a minimum of three-hours in length and held between the hours of 8am and 5pm. The session can start no earlier than 8am and must end no later than 5pm e.g. Open Pistol 8am-11am, Open Rifle 1pm-5pm.

Cancelations

- The \$20.00 range fee is due even if the PP is canceled
- If a PP session is not going to be utilized, it must be canceled
- Repeat cancelations, sessions not canceled and not utilized, Open session requirement not being fulfilled – will result in loss of PP privilege and a review of the RSO’s status

Exemptions

Exemptions to the PP rules can be requested via the Senior Range Manager (extended hours, number of shooters, weekend use, etc.). Exemptions are made on an individual basis and do not established a precedent for future exceptions.

Policy Elucidations: The Senior Range Manager has the authority to modify and/or interpret PP policy – taking in consideration the intent of the policy and the best interests of the EDGC.
